#### THE MINUTES OF GENERAL SYNOD 1927.

SESSION CIV.

Minutes of the General Synod of the Reformed Presbyterian Church in North America, 1927.

Session 104.

The General Synod of the Reformed Presbyterian Church met in its 104th Annual Session in the First Reformed Presbyterian Church, 7119 Frankstown avenue, E. E., Pittsburgh, Pa., en May 18, 1927, at 8 P. M., and was opened with a sermon by the retiring Moderator, the Rev. Thomas Whyte, of the Third R. P. Church, Philadelphia, who took for his text Heb. 12:24, "And to the blood of sprinkling which speaketh better things than the blood of Abel?" The sermon was a clear, forceful and interesting presentation of the doctrines of the Word of God upon the sacrifice of Christ for sin.

After the sermon the Moderator constituted the Court with prayer, and announced that any matters needing immediate adjustment would properly be presented at this time.

Dr. Alexander Savage offered the following resolution

which was adopted:

Resolved, That the hours for convening and adjourning the Court be as follows: Meets at 9 A. M., fast time; adjourn at 12 noon; meet at 2 P. M. and adjourn by resolution, and that the first half hour of each morning's session be spent in devotional exercises.

Hammond was duly received into the ministerial fellowship of the above named Presbytery and is now pastor of the Huntsville N. P. Church, Logan county, Ohio Rev. The Woman's Missionary Societies and Ladies' Aids are doing a commendable work in raising money and furnishing clothing for the needy in connection with our Home Mission work, also Foreign Mission work, and we have pleasure in stating that they do not weary in well doing. The Ohio Presbytery reports as follows: Two meetings have been held since the last report to General Synod, both in Cedarville, Ohio. The first was held June 14, 1926, to act upon the request of the Cedarville congregation to be dismissed to the Dayton Presbytery of the Presbyterian Church, U S. A., permission to do so having been previously granted by General Synod. The request was granted, and the necessary papers were made out in due order. Thus passed one of the landmarks in the history of the Reformed Presbyterian Church

At the same time Rev. W. P. Harriman asked for and received a letter of dismissal to the same denomination, and still continues to serve as pastor of the Cedarville congregation in its new denominational

The regular meeting of the Presbytery was held May 17, 1927, when the regular routine business was transacted, and delegates were appointed to this meeting of General Synod.

The Cedarville congregation, for the year just closing, continued to make its benevolence contributions to the Home and Foreign Mission Boards of the Reformed Presbyterian Church and to Cedarville College. This was in accordance with engagements entered into before the transfer, but will not be the case hereafter, except that for the current year they have voted 30 per cent. of the benevolence contributions to Cedarville College. The women of the congregation have been very generous and industrious in supplying the needs of the children of the

Kentucky Mission.

The Presbytery appreciates the support that the General Synod renders to the Cedarville College and to the Seminary, and hopes that this zeal will not be diminished because of the anomalous situation in

which we are placed

#### THE REPORT OF THE WESTERN PRESBYTERY

To the Reformed Presbyterian Church, to meet in Pittsburgh, Pa...

The Western Presbytery of the Reformed Presbyterian Church in North America has held but one meeting since the last meeting of General Synod, that being on May 11, 1926, at Sparta, Ill. The ministers of the Presbytery are so widely scattered it was decided to dispense with the semi-annual meeting to avoid expense and to require the Moderator to call a meeting whenever any business demanded the call. There are now five ministers in the Presbytery, one in India, one in California, one in Kentucky, one in Illinois and one in Kansas. There are two vacant congregations, Bethel and Concord. Statistics sent to Presbytery were not complete and it is impossible to give a tabulated statement of gains and losses, but the losses seem to exceed the gains.

We have no young men who are looking forward to the Gospel

ministry.

Rev. Ramsey, assisted by his laughter maintains the work faithfully in Los Angeles, but feels that the end of his service is drawing He, because of his weakness has not applied for an appropriation, but the Presbytery feels that the usual appropriation of \$700 should be made as his expenses will continue even though he is unable to preach, and that in something over 50 years of faithful service this minister of Christ has proved himself worthy and is entitled to the love

and care of the church which he has so faithfully served.

Miss Martha J Ramsey is desirous of continuing the work and the Presbytery would present to the Board of Domestic Missions the

matter of granting an appropriation for her The Republican City congregation made request for an appropriation of \$250 supplement and Presbytery would refer this request to the

Board asking that it be granted.

The Sparta congregation has been regularly and satisfactorily supplied by Rev Rogers, of the U. P. Xenia Seminary. Rev Paul W. Duncan, of Coulterville, has supplied Concord part of the time, but the roads have been impassable for several months and the good brethren of the Concord Church are very much discouraged.

The Sparta congregation has sustained a great loss in the passing of Mr. A. B. MacMillan. Coming so soon after the death of his faithful brother, Mr. T. L. MacMillan, the Session thus reduced to two men. Recently an election was held and at the spring Communion three additional members were ordained and installed. They are Hugh A. Dickey, James Roble Stewart and Martin Patton Wilson. Three elders were also added to the Republican City Session. They are Nevin W. Chestnut, Elmer Henry and James S. Chestnut.

#### LETTER FROM DR. RAMSEY

To the General Synod of the Reformed Presbyterian Church, to meet in Pittsburgh, Pa., May 18, 1927. Dear Brethren in Christ:

In the good Providence of God I am permitted once again to address you by letter. I wish to testify to the great goodness and love of God extended to me during a long and varied experience in the ministry. We can say with the Psalmist "The Lord of us hath mindful been, and He will bless us still." From my earliest childhood I never had any other thought or desire than to be a minister. God granted my desire. And I may say also that I never had any other thought or desire than to be a minister in the Reformed Presbyterian Church, and beyond all this I may say I have never during all these years had any thought of leaving or desire to leave the Reformed Presbyterian Church. I have been satisfied with its doctrines and order and with its treatment of me as a minister. Our church does not have many honors to bestow, nor many high places to occupy, nor inviting fields to work, nor worldly inducements to attract the attention of young men seeking a life work, but it has honors, and a large held, and great attractions for those who "look not on the things that are seen, but on the things that are not seen." The Christian church is not as united in its efforts as it should be. Divisions do much harm, but false prophets do more harm. Jesus Christ and His Gospel message is the life of the church and evangelism now as they always have been. Modern thought and modernist theology is taking the life and power out of the evangelistic movements of the present day. There are too many of these false prophets, not only in our home land, but also in our foreign mission fields, to take away Jesus Christ, the need of repentance, faith, regeneration, etc.

Different plans are being resorted to, but none is so successful as

the pure Gospel message in leading the sinners to the Saviour.

We would arge upon our entire church the necessity of evangelistic work and that our ministry should preach the simple Gospel of our Lord, which is the power of God unto salvation to every one that be-

lieveth; to the Jew first, and also to the Gentile

Would it not be possible for each of our congregations to arrange special services during the coming year at some convenient time that the people might be stirred up to magnify the Lord Jesus Christ, our crucified yet risen Saviour? Let us lift up Jesus Christ before the world that He may draw all men unto Him.

#### SABBATH OBSERVANCE

To the General Synod of the Reformed Presbyterian Church in North

Your Committee on Sabbath Observance would submit the follow-

ing report:

Many times since the world began men have been obsessed with the idea that anything as old as the Sabbath day ought to be discontinued on the plea of progress, and just as often a period of backsliding has followed. The Sabbath, or holy day, of the week is a venerable institution, so also is the sun which shines from heaven upon the earth. Neither can be spared without terrible havoc following. Men cannot abolish the sun, neither can they abolish the Sabbath, though they may destroy themselves in the effort.

The need of a rest day, a day when the body may rest and the mind and spirit be busy in the things of the kingdom of God, is written in the constitution of man. It is written in the word and in the experiences of man, but it is also written in man's physical, mental and moral makeup. And the individual who can take heed of that fact without the costiy experience of the disaster which follows the disregard for that law is

fortunate indeed.

Your committee believes that this generation is on the down-grade so far as keeping the Sabbath is concerned. The introduction of so many complex institutions, such as railroads, telephones, electric lights, automobiles, etc., has created a demand for service 24 hours in the day and seven days in the week. The dairy system is formed and conducted, not in accord with the actual needs of man, but in accord with their carnal notions. Doctors are often called on Sabbath when they would not be called if it were a week day Funerals are arranged for Sabbath because it is more convenient for people to attend. Excursion trains are billed and advertised for the holy day because then the crowds will come.

In the complex conditions of life which have arisen in the last two or three decades much Sabbath day work is necessary, but the vastly greater proportion of the work done is without any justification. If people knew that all the filling stations would be closed on Sabbath they would learn to secure gasoline, oil, etc., on Saturday; it is easy enough to learn. If your tank sprang a leak on Saturday night, or if thieves came and took what gasoline you had, then one filling station could serve such cases—why have twenty? Stations might take turns to keep open for such emergency cases. The running of trains, street cars, hacks, etc. seems to many to be a real necessity, but certainly most of the traffic which they handle is secular; picnic excursions; ball games, visiting trips, etc., etc., and that is coming to be very common.

The most serious side of the case is not that men want to keep the Sabbath and cannot, but that they could keep it and will not, and the church is not standing bravely for the teaching of God's Word, but in very many instances the church is trimming her course to please the

popular demands.

A Y. P. S C. E. in a prominent church decided that it would be more entertaining to have a dance upon Sabbath evening than to hold an old-fashioned prayer meeting, so they moved out the chairs and held a dance. Some "old fogies" objected, and the papers report the pastor as saying: "If the young folks wish to enjoy themselves let them do so: there is no harm in that." The Sabbath "Social hour" is simply a party held with the pretense that it draws people to church, and it

often does draw them, but they generally skip out before the hour set for services.

The notion that a divine law can be set aside at the will of man

has brought havoc in thousands of instances.

There are so many human cattle who care not at all about their own welfare or the welfare of the community that it seems that if desirable conditions are ever at a ned the law would have to compel some consideration for the holy day. But when an effort is made to enforce Sabbath laws, which are already upon our statute books, or to pass appropriate legislation where it is lacking, we are confronted by bitter opposition of a religious sect which seems to feel that it alone is able

to interpret the civine Word.

When the Hon. W. C. Lankford, of Georgia, spoke so eloquently in behalf of H. R. 1033 Sunday Rest bill for the District of Columbia, the religious sect which claims perfection of interpretation for itself at once spoke out in very severe terms, charging that an effort was being made to deprive people of religious liberty, "a return to the dark ages demanded," "advocates of the inquisition active," "an effort being made to force religion on to people by law" Such were some of the pleas with which a sectarian class would oppose the effort to check and curb Godlessness and regardlessness in our national capital. When a socalled church becomes the avowed and bitter opponent of a holy day of rest Satan will surely be pleased with such a church, and yet there is no organized or as strong enemy to a holy rest but such a sect. I quote a few sentences from the speeches of the Honorable W. C. Lank-

"The pace of life is so intense and the race so keen that out of sheer defense man must keep the Sabbath day or pay the price of body broken and mind that has fagged."

"Take profit out of Sunday amusements that are tolerated and they

would not exist."

"Sabbath desecration is the pirate of the home and he who does not keep the day undermines the possibility of keeping his home.

"The Sabbath day is the charter of liberty to the sons of to.l."

"Forty-four of the forty-eight States of the Union have laws protecting the Sabbath as a day of rest and worship. The District of Columbia is without any such law"

These laws are of inestimable value to the Republic in that they protect the day for implanting in the hearts of the people those moral

and spiritual truths without which democratic government would fail." "Washington, the nation's capital, should be the country's model orighteousness, rather than its Sodom of ungodliness."

We rejoice that there are so many men such as Honorable Lank-

ford who stand strongly for right laws and their enforcement.

We take delight in the brave, consistent attitude of an elder of our Darlington congregation, Hon John G. Marshall, of Beaver, Pa., who has worked faithfully for right legislation in the Pennsylvania Legisla-

We are happy to believe that the Reformed Presbyterian Church maintains high ground, both in her declaration of principles and in her

practice upon this important matter.

God's faithful servant once said to those who commercialized the Sabbath: "Ye bring more wrath upon Israel by profaning the Sabbath," Neh. 13:14, and if a disregard of God's laws was visited by divine wrath once, it will again. God never changes. Man's notions are of little weight when they are set in opposition to the eternal laws of God.

Your committee would submit the following recommendations:

1. That Synod call upon our membership to be steadfast in maintaining in practice a Scriptural observance of the Sabbath day.

2. That Synod urge upon our members and churches all possible support in the enforcement of right Sabbath legislation and the encour-

agement of new legislation to the same end.

3. We recommend that we heartily approve of the Sunday Rest bill for the District of Columbia; that we express our appreciation of the work of Hon. W. C Lankford, of Georgia, and that we call the attention of our Senators and Congressmen to the importance of such legislation.

Requesting the Synod to consider and endorse these recommen la-

tions, we submit our report.

#### REPORT OF THE SUPERINTENDENTS OF THE THEO-LOGICAL SEMINARY TO THE GENERAL SYNOD OF THE REFORMED PRESBYTERIAN CHURCH

The Board of Superintendents of the Theological Seminary met at 8 A. M. in the Cedarville College building and was constituted with prayer by the chairman. Rev. Thomas Whyte, of Philadelphia Three students presented trial homilies before the Board. The Board had under their consideration examination papers and passed on the same, authorizing the professors to credit each student with the work done.

The professors submitted reports of the work done and of the conduct and faithfulness of the students. These reports are herewith submitted to the Synod and give a very definite and satisfactory outline of

the work which is being done in our Seminary.

Of the ten students who are attending the Seminary not one is a member of the Reformed Presbyterian Church. The Superintenden's regret that our own young men are not offering themselves for the Gospel ministry, and yet as Christianity is greater and more important than any private interpretation of it, so it is an occasion of thanksgiving that as many as ten are availing themselves of the training which our church can give. If it is a privilege to teach the people, is it not a higher privilege to teach the teachers of the people? We cannot afford to cease to serve because God in His providence has changed the channel through which we are serving. Besides 25 per cent, of our own congregation are being served by men who have been trained in other seminaries. Certainly it would be unworthy of us to neglect to do what we can for the advancement of the kingdom of Christ simply because we do not see where it is going to profit the Reformed Presbyterian Church as a denomination.

The only hope of having young men in our Seminary in the future

is to keep our Seminary open.

The Board would make the following recommendations:

1. That September 4 be set apart as a day of prayer that God will "send faith laborers into His vineyard" and request that ministers

present the matter from their pulpits.

2. That the Trustees of the Theological Seminary be requested to pay to Cedarville College the sum of \$130 for rental and that they issue an order on the Treasurer of the Theological Seminary fund, Mr.

W. J. Imbrie, for the payment of the same.3. That the Trustees of Theological Seminary, according to a previous order, be requested to pay to the Treasurer of Cedarville Col-

lege the sum of \$500 and that they issue an order upon the Treasurer of the Board, Mr. W. J. Imbrie, for the payment of the same.

4. That the Trustees in Theological Seminary be requested to pay to the professors in Theological Seminary as follows: To Prof. W R. McChesney, \$1000; to Prof. F. A. Jurkat, L.L. D., \$1000; to Prof. B. E. Robison, \$600, making \$2600 in all, and that they issue an order upon the Treasurer of the Board of Theological Seminary, Mr. W. J. Imbrie. for the payment of these amounts.

That the Trustees of Theological Seminary be requested to pay to the students of the Gospel ministry who are under the care of any of the Presbyteries of the Reformed Presbyterian Church the amount of \$150 a year for student ail and that they issue an order on the Treasurer of the Lamb fund, Mr. W. J. Imbrie, for the payment of the same.

We recommend that the traveling expenses of the Board of Superintendents of Theological Seminary be paid and that the Board be requested to issue an order on the Treasurer of Theological Seminary, Mr. W. J. Imbrie, for the payment of such expenses as follows: Thomas Whyte, \$31.25; L. A. Benson, \$10.81; D. H. Hammond, \$5.

#### REPORT OF THE COMMITTEE ON TEMPERANCE

To the General Synod of the Reformed Presbyterian Church in North

America, met in Pittsburgh, Pa., May, 1927 The issue of the warfare against sin is never decided by one battle. Satan is persistent; he is never short on the quality of perseverance, and so those who imagine I that writing prohibition into the Constitution of the United States had settled the matter have been rudely awakened: some to renew the conflict with more vigor and wisdom, and some to despair of ever attaining victory. The poet took some liberties with the hard cold facts when he said:
"Truth crushed to earth shall rise again,

The eternal years of God are hers, But error wounded writhes with pain, And dies among its worshipers"

Error and sinful habits ingrain themselves very deeply into the

dispositions of men, and men will fight for their so-called "right" to do wrong who would not fight for the King of Glory. The spirit of selfishness is at the bottom of the liquor business and the habit of drink. "My way," "my business," "who knows what I want better than myself?" "who has authority to dictate what I shall eat or drink?" Thus they state their case. But some ten years ago the Government was deciding where some four miliions of our men would camp and what they would eat an I drink and when and where, and was there anything strange about it? Did anybody think it absurd or unfair?

A man who began to smoke and chew tobacco at the age of fifteen years reached the age of sixty-five and was afflicted with a shortness of breath and a very annoying pain in his heart, consulted a physician; he was told that he had what was called "tobacco heart" and that he must at once quit the use of tobacco in any form or prepare to move from this world to the next. After reflecting a little he decided that if he moved to the next world with his pipe he would doubtless be sent to the regions of smoke, and as he did not fancy that idea he decided to quit tobacco. After a terrible struggle against the habit for a year he announced: "Boys, if any of you will use tobacco for fifty years and think you can stop, I can tell you one thing and that is, before ever you can stop you have got to have your own consent good and plenty."

Now that is the lesson which the American people are learning concerning the liquor business. Many of us knew it all the time; some have not grasped it yet. But Satan will not be easily cast out. "This

kind cometh not forth but by prayer and fasting"

But didn't we get our own consent good and plenty? Forty-six States out of forty-eight seems so, and are the soldiers of the common good, the soldiers of Jesus Christ, enlisted for but a single battle? Nay, they serve for life; there will be no retreat. "Our Master never taught us to beat a retreat" in the face of a foe to mankind or to His honor. There can be no surrender; there can be no compromise. America is following the advice of her early pioneer as she is pioneering the way for the worl!. "Be sure you are right, then go ahead," and that is our present duty and we will go ahead Every victory won is that much nearer deliverance from this worse than an Egyptian bondage. But only one outcome is conceivable. We will be a sober people; lust shall not rule us. The greed for gain, illicit gain, cannot marshal the forces in this land that can match the soldiers of the cross, and there is a vast difference in the staying qualities of such soldiers. It will require the struggle of a generation to completely cast out this demon of drink. But what generation of men has done more for advancement than the generation which achieves such a victory? It is worth all of the stress and struggle to belong to that generation which so bravely dares an l so nobly bears on for such high achievement.

We are learning how the enemy fights. They would gladly take over the business of enforcing the law in order that they may make it seem like a farce. Men anima ed by greed are often placed in positions of responsibility and trust. These must be sifted out. The people must choose, instruct, watch, reward or punish public officials When it is plainly evident that honesty and faithfuiness will be approved and rewarded, and that complicity with the enemy shall be regarded and punished as treason the beginning of the end will be in sight; victory draweth nigh. Little by little we are gaining ground. Moral interests, religious interests, business interests, interests of public safety on our highways, all combine in demanding that the Eighteenth amendment

be properly enforced

The fact that some men in high places, as for instance Nicholas

Murray Butler, of Columbia University, are outspoken against the Constitution of their own country, will have little effect save to prove them as unworthy of such a country. The fact that some States, such as New York and New Jersey, basely nullify the law of the nation can have no final effect in preventing the ultimate triumph of the movement against man's greatest foe.

The Church of Jesus Christ has led in this reform. She has given the vision to see the way and the decision to take it, and the seasoned persistence which insures that the outcome shall be glorious.

Our own little church has been active and on the right side. In the Cyclopedia of Temperance and Prohibition, published by Funk & Wagnalls, 1891, is recorded, page 584, the attitude taken by this Synod at its meeting in 1889, Mr. J. W. Houston, of Pittsburgh, Pa., being chairman of the committee which brought in the report. I quote from

the report:

"The Reformed Presbyterian Church has in the past stood forth the champion of oppressed humanity. In the last great conflict she was among the foremost to lift her voice to condemn slavery and to demand the liberation of the slave. A mightier conflict is upon this nation today; inaction is opposition. We arraign the liquor traffic as the crime of erimes, as the overshadowing curse of the age, as the prolific parent of vice, misery and pauperism We arraign the saloon as the peculiar institution of the devil, as the inveterate roe of God and man, as the school of anarchy, as a constant menace to the home, the church and the State, as an uncontrolled and uncontrollable power that has successfully defied all restrictive laws. The logic of experience has demonstrated that there is but one successful remedy, namely, exterminationprohibition."

Brethren, let us count it an honor to be permitted to stand here and announce that we who have inherited so much from the fathers of our Church stand just as they did in our opposition to this great iniquity. Let us take courage and go forward. "Here we stand; we cannot do

otherwise; may God help us."

Walker Miller, Department Secretary of the Atlantic Agency of the American Bible Society, and that we declare it to be the sense of the General Synod that the work of the American Bible Society is a most worthy one, which we heartily endorse, and commend it to the favorable consideration of all our congregations recommending that they, according to their several ability, take up an offering for the benefit of the American Bible Society, Bible House, Astor Place, New York City."

#### SIGNS OF THE TIME

When we think of conditions in the world today and see all the evil that is going on as is placed before the public in our daily newspapers and certain magazines we are very prone to look upon mankind with doubt and despair. But is it fair for us to judge humanity from just what we read? Some one has said the best of history has never been written. When we think of the history we have studied, sacred and secular, has it not been rather a dark picture of man? History has largely been made up of disputes, strife and war Humanity is humanity the world over and has been and continues to be so. Man has possessed strife, enmity and evil down through the ages, nevertheless every man has some good quality and mankind as a whole has been created with the image of God stamped upon him in no uncertain manner More than this, Go1 has taken darkness, enmity and despair and evil and put about them unbreakable chains of better things. Christ the King of Glory and the ruler of earth and the Prince of Peace has been sent by the Father to subdue Satan and sin and to conquer this world, also the Holy Spirit, the Third Person of the blessed Trinity, is working harmonicusly with the Son of God in performing this gigantic task. Can we doubt God? Can we doubt Christ? Can we doubt the Holy Spirit? Can we doubt humanity when she is under the care of a loving Father and a Saviour that is able to save to the uttermost, and a Teacher that will show unto us the light of heaven? Can man fail under the guidance and protection of the Omnipotent, Omniscient and Omnipresent God? Not so. Are we going to judge the world by its great warriors, the criminal class and the scum of the earth, or by the teeming millions who are marching under the starry banner of the Christ? Sometimes we forget the thousands of missionaries and ministers of the Gospel and Christian leaders and teachers who are giving full-time service for the King, also the millions of Christian fathers and mothers that are loyal and true, also boys and girls.

As we look out upon the world today and turn our magnifying glasses upon the mass of humanity we see many perplexing problems; there is the race question, the crime wave, unsettled conditions, Bolshevism and threatening war clouds, also the problem of capital and labor, and many others. These problems, humanly speaking, are beyond us to solve, as is the great task of the evangelization of the world. However, the signs of the time point out to us very plainly this encouraging fact that the Spirit and power of the Father, Son and the Holy Ghost are working mightily and bringing about unspeakable transformation.

Cedarville College is just closing the thirty-third year of its work. It was opened for the training of both sexes September 19, 1894. thirtieth annual commencement will be held June 3, 1927. Bishop Theodore S. Henderson of the M. E. Church, will be the speaker of the day. A class of seventy-five will be graduated. Of these, nine will receive the Degree of Bachelor of Arts in the Liberal Arts Course, eighteen will receive the Degree of Bachelor of Arts in the Arts Education Course and will also receive the State Provisional Certificate for high school teachers in Ohio; thirteen will receive the diploma for completing the work in the Two Years' Normal Course and the State Provisional Certificate for elementary schools; thirty-one will receive the certificate for completing the one year elementary course, two will be graduated from the Department of Music, and two will be graduated from the Preparatory Department. This is by far the largest graduating class in the history of the college. It will bring the total alumni list up to almost four hundred. The graduates of the college are located in all parts of the world and are in all vocations. One hundred and twelve are professors in colleges and teachers in the public schools; forty-nine are in business; forty-eight are housewives; forty-six are ministers of the Gospel; nine are physicians; nineteen are farmers, five are lawyers; one is a judge; one a Senator, and one a prosecuting attorney. Nearly two thousand others have received a partial education in Cedarville College. The enrollment of students in all departments of the college this year is two hundred and forty-three, counting none twice. The outlook for next year is that there will be at least three hundred students in attendance

The faculty and instructors number twenty-two.

The Alford Memorial Gymnasium was remodeled and enlarged this past year. Mr. W. J. Alford, Sr., a son of the late beloved Dr. John Alford, gave \$20,000 to this project. It is one of the most beautiful and

capacious buildings of its kind in southwestern Ohio.

By arrangement during the year, the Department of Education of Ohio will open a State Normal School in Cedarville College in September. Three teachers' courses prepared by Dr. Bagley, of Columbia University, will be offered. Five professors will have charge of the work. They will be in addition to the regular faculty of the college. The State will provide \$15,000 for the first year's work and \$30,000 for the second year's work. The school will conduct its work in the Science Hall of the College. This will make Cedarville College one of the best and strongest schools in Ohio for the training of elementary and high school teachers.

Two presidents thus far have served Cedarville College. The first, Rev. David Mckinney, D. D., began his work in 1894 and resigned in June, 1915. During his administration the college built up from the ground. It grew from thirty-six students to over one hundred and from an endowment of \$20,000 to \$83,000, and from a rented house to three buildings. Under the present administration, the Student Body has increased from over a hundred to two hundred and forty-three. The buildings have increased by one, the Science Hall, and the Alford Memorial has been remodeled into practically a new building. The endowment has grown from \$83,000 to \$208,000. The endowment and buildings and campus are valued at \$408,000.

The personnel of the Board of Trustees remains the same as that of last year. The Board held its regular annual meeting last June. Several meetings of the local members of the Board were held during the year in connection with the remodeling of the Alford Gymnasium.

The college was gratified to receive notice recently of the bequest of \$25,000 by the late Miss Arbuckle. This bequest came through the influence of Dr. J. Alvin Orr, an alumnus of Cedarville College and the pastor of Miss Arbuckle. It was also due to her Christian spirit and her confidence in the college. This together with former gifts from her, makes a total of \$35,000 which she gave to Cedarville College. She is the largest single giver to the college in its history.

The Board of Trustees has beautiful shrubbery planted during the

year to beautify the campus.

The influence and prestige of the college are growing with every passing year. The hour is here when, if every friend of Cedarville College, will do his and her part in prayer, and gift, and word, and work, the college will speedily receive all of the endowment which it needs to become a standard college. Only \$292,000 needs to be raised for the endowment.

Over and above the income from the Endowment Fund and tuition the college will need \$3500 to meet its current expenses next year. This will require a minimum offering of at least \$2 a member from the entire church. We are grateful for the liberal and hearty support of the pastors and members of our church this year. No one should give less than \$2 next year and many will have to give more in order to raise the \$3500.

We present the following recommendations to General Synod:

First—That each congregation under the care of General Synod, unless it have some other method of raising funds, set apart such Sabbath or Sabbaths of the year as may be deemed wise to contribute benevolent offerings for the current expenses of the college, and that the notice of these offerings be made from each pulpit in the Church at

least two weeks before the offering is taken.

Second—That the pastors preach upon themes pertaining to Christian education in which the specinc vartues and needs of Cedarville College shall be presented upon the day that the church offerings are announced.

Third—That Sabbath schools, Missionary Societies, Christian Endeavor organizations have their attention called to the needs and the support of Cedarville College.

Fourth—That General Synod enlist the co-operation of all pastors and elders as well as other leaders of the church in calling the attention of our youth to Cedarville College and urge them to secure their education in Cedarville College.

Fifth—That from time to time the pastors publicly urge upon their congregations to remember the college in their prayers, collectively

and individually.

Sixth—That the Board of Trustees of the Theological Seminary Fund be requested to issue a certificate to the treasurer of the board's funds to pay the amount of five hundred dollars this year to the treasurer of Cedarville College not later than the month of November, 1927.

Seventh—That the Board of Trustees of the Theological Seminary Fund be requested to issue a certificate to the treasurer of the board's funds to pay the annual rental of one hundred and thirty dollars to the

Treasurer of Cedarville College.

Grateful to you, fathers and brethren, and to the congregations of our church for your faithful, generous, and united response and liberality to Cedarville College and thankful to Almighty God for his manifold blessings to the college and beseeching your continued united support and the favor of God and praying the blessing of the Great King and Head of the Church upon you in all of your deliberations, we respectfully submit the foregoing report.

Moderator called Court to order, requested Rev. W. R. McChesney that he constitute the Court with prayer.

Roll was called, Minutes were read and approved.

The report of the Board of Foreign Missions was presented.

#### REPORT OF THE BOARD OF FOREIGN MISSIONS

The Foreign Mission Board would respectfully report to General Synod as follows:

During the past year our missionaries, Dr. Taylor and Mrs. Taylor. together with their helpers, have carried on their work with a good

degree of success in the face of many difficulties.

The Board has reason to be thankful to God for His longsparing mercy and providential care over the entire mission. Their personal labor reports have been received and in due time will appear in The Advocate for the benefit of the entire church. These reports show that there are several schools in which the boys and girls are being given the equivalent of a common school education

Not long after the doctor returned to India he suffered an attack of fever and since then he has been under the necessity of taking medical treatment constantly. The work he is doing is too much for him under these circumstances. For this reason as well as for others we are now face to face with the task of sending our at the earliest possible date some one to help him in the work. Miss Smiley being unable to go as she had expected broke into our plans and made it necessary for us to seek elsewhere for one to take her place. In view of this providential hindrance the Board offered the following resolution: Resolved, That the Board of Foreign Missions received with delight the voluntary offer of Miss Smiley to become a missionary under the care of the

Board in our mission in India. We were especially grateful not only because of her natural and acquired ability for this service, but also because she is an esteemed daughter of the late Rev. W. J. Smiley, who so long and faithfully served our church. It is now with deep regret that we are compelled to accept her withdrawal of her offer because of providential reasons over which she has no control. We tender her our sympathy and consolation in this our mutual disappointment, realizing that God often accepts the will for the deed.

Since our last meeting Mr. Lee B Tedford, of Aberdeen, Idaho, renewed the offer of his services to go to India, and has sent in his application for an appointment by our Board as a missionary to India. Mr. Tedford comes to us with the best of references, and has placed his membership in the Duanesburgh congregation of General Synod. He has also applied to be taken under the care of the Philadelphia Presbytery. In making this change from the head of the public schools of Aberdeen to go as a missionary to India he surely makes a great sacrifice in the worldly sense. We sincerely hope that the Board and the Synod will take such steps as will enable us to send him out during the coming season.

The budget sent in by Dr. Taylor for the coming year is the same as last year, but for sufficient reasons was cut down to \$5000. Dr. Taylor is very anxious that Mr. Tedford be sent out this year so that he can get the language well in hand by the time that Dr. Taylor's next furlough is due The doctor feels that it will be necessary for him to spend at least five years in America to recuperate his health. During this time he thinks that Mr. Tedford can carry on the mission successfully in his absence.

Do we realize the work our missionaries are doing or the trials they have to endure? Let us remember that it requires a level head, a strong body and a determined will and a consecrated heart to be a successful missionary. These qualifications our missionaries have and we now

present one of equal character as a co-laborer.

At a meeting of our Board, May 19, 1927, Mr. Tedford's application to be received by the Board and sent out to India as a missionary was accepted, and it is hoped that all necessary arrangements will be completed in the near future, that he may be ordained to the ministry of the Gospel and fully prepared for the mission field. The income from the Buchanan bequest will be sufficient to enable us to carry forward this part of the work. The budget was cut down some for this year to assist in clearing up the deficit of the preceding year. The Treasurer's report will show the status of our finances.

In order to carry on our work successfully we call on the entire church to rally to the support of the Board with their means that the Treasurer may be able to meet his obligations during the coming year. These contributions should be taken up and sent in as early as possible. It seems impossible to establish any rule that will suit the condition of every congregation. Let every one use the plan that will prove the

best under the circumstances.

Our missionaries are doing good work and should have the hearty

support, moral, spiritual an I financial, of the entire church.

The Board is sensible of its great loss in the recent death of Mr. A. B. McMillan, of Sparta, Illinois, who for many years was a member of the Board, and also its Treasurer. We desire to place on record our appreciation of the value of his service and also convey to Mrs. McMillan our heartfelt sympathy in this the time of her sore trial and becreavement. May the God of all grace comfort and sustain her in all

her trials and sorrows.

Praying for the blessing of God to be upon our mission and the entire church we would respectfully submit this our report.

Church, and it has been our privilege to see this completed in the ordination and installation of Rev. A. E. Gregg on Thursday evening, May 19. This was a delightful service and was attended by a large congregation and the evidences are that Rev. Gregg enters officially upon the pastorate with the brightest prospects for real work in the kingdom

Last year the General Synod passed a resolution asking the Pittsburgh Presbytery to receive Rev. Mackey when he presented his application (see page 55). The report of the Pittsburgh Presbytery does

not show any action in the matter.

As to the Ohio Presbytery your committee regrets the departure from among us of those who have been long associated with us. We rejoice that some have remained faithful and we desire to commend them for it. We appreciate the loyalty of the ministers of this Presbytery to the Synod.

The committee recommends that the Los Angeles property be sold whenever a proper offer is received, that the loans of the Board of Church Extension and other debts be paid, and the balance be turned

back to the Home Mission Board.

On motion the Treasurer of the Home Mission Board was instructed to reimburse Rev. Robert W. Stewart the sum of \$130 for two months' salary which he had paid Miss Calla Turner.

The following requests for financial aid was presented by Presbyteries: Philadelphia, \$200; Pittsburgh, \$300; Western, \$600, to be divided as follows: Rev. S. M. Ramsey, \$200; Miss Martha Ramsey, \$200, and Clay Center, \$200.

The Board presented the above scale of appropriations for General

Synod's approval.

Rev. R. W. Stewart's report was read. It was interesting and inspiring to all and was received, approved and ordered printed in the minutes or Synod.

The report of Rev. R W. Stewart was as follows:

To the General Synod to meet in the First Reformed Presbyterian

Church, Pittsburgh, Pa., May 18, 1927, at 8 P. M.

Our school the past year opened the third week of July with a very good attendance. As we had one less teacher than heretofore, it was necessary to change the arrangement of quite a few seats in the school building in order that the pupils might all be placed in two rooms. The attendance was good throughout the year and better during the last two months than it ever was since my arrival at Houston. Those teaching the past year were Miss Maude Howell, Miss Calla Turner and myself. Mother Stewart left in August for a month's vacation with relatives an I she was greatly missed by ail. We were all very glad when she returned in September for the rest of the school year, but she was called away on October 23 on account of the sickness of her daughter. She has not returned and her presence has not only been missed in Anath Home, but in the entire community.

Although the work of the school has shown quite a bit of progress, the work of the church has not shown the same amount of progress. We have had preaching from several outside ministers who have brought us very fine messages from the Word of God, yet there was

not the response that we thought there should be.

We were very sorry that the farm, which is so badly needed, could not be purchased. The one pressing need at the present time is a cook stove at the dormitory. Nothing can be cooked on the old stove without getting a coating of ashes.

We are glad to report that the Radio Fund started by Mrs. Lauter-bach has increased to \$41.75. It has been gradually increasing through

the year.

We are indeed grateful to all those who have contributed to the help of the work in Kentucky. Many and varied have been the gifts during the year. Scholarships were given so that we were able to help five boys and girls who otherwise would have received no schooling at all. May the Lord bless those who have so kindly given for the help of others.
